#### Personal Information

Provide your personal details in the spaces provided:

- Full Name: Enter your first, middle (if any), and last name.
- Date of Birth: Use the format DD/MM/YYYY to enter your birth date.
- Contact Details: Provide your phone number and email address and your postal address. Ensure these are active and regularly checked as this will be our primary means of communication.

## Membership Type

Choose the type of membership you are applying for:

- Standard Membership: This is for standard membership with full access to club activities.
- Family Membership: Residing with a member of the club who holds a Standard membership.
- Junior Membership: Between the age of 12 and 18 years of age. Juniors must be always accompanied by a parent/legal guardian.
- Concessional Membership: This membership has a criteria of providing evidence to the committee that you are in possession of:
  - Seniors Card.
  - Veterans Card (must be gold TPI)
  - Disability evidence/Government Health Concessions
  - Other deemed by the COM
- Affiliate membership: This level of membership does not provide any voting rights at general
  meetings, no firearms support and no range key for access to the range after hours and not
  recognised in the association's monthly trophy matches. You must be a member of a recognised
  shooting association. No nomination fee is payable
- Associate membership: You are not permitted to take part in any club matches sanctioned by the association.

  - \$170 pro rata from 1<sup>st</sup> of July
  - Nomination fee not applicable
- Concessional Membership
  - \$170 pro rata from 1<sup>st</sup> of July
- Affiliate Membership
  - \$170 pro rata from 1st of July
